Objective

1. Objective

The Green Party of Canada is committed to supporting our Electoral District Associations in the important responsibility of candidate selection. Local EDA members work in partnership with the Leader to ensure a democratic selection process, excellent representation, and a rewarding campaign. This guide is intended to help meet these goals.

1.1 The following procedures for candidate nominations were adopted by the Federal Council in February of 2009, for use by the Electoral District Associations of the Party, and supercede all other rules affecting the selection of a candidate for the Green Party of Canada.

1.2. Any action or decision that may be taken by the Leader or the Campaign Committee under these procedures may be taken by any of their designees.

Definitions and Abbreviations

2. Definitions and Abbreviations

In these pages:

- a. "Act" means the Canada Elections Act.
- b. "Campaign Committee" (CC) means the Campaign Committee established by Federal Council as the strategic arm of the Green Party of Canada.
- c. "Candidate" means any person who is selected to represent the Green Party of Canada to seek election as a member of the House of Commons for an Electoral District in an election.

- d. "Chief Executive Officer" (CEO) means any person appointed or elected to by the members of an Electoral District Association to that position.
- e. "Election" means any federal general election or by-election to elect a member or members to the House of Commons.
- f. "Electoral District" (ED) means a place or territorial area that is entitled to elect a member to serve in the House of Commons.
- g. "Electoral District Association" (EDA) means an association registered by Elections Canada in a federal electoral district.
- h. "EDA Executive" means the persons appointed or elected by members to positions in the governing body of an EDA.
- i. "Eligible voting member" means any person who meets the requirements fixed by the Green Party of Canada Constitution entitling the person to vote at a meeting.
- j. "Federal Council" means the Council as described in Article 9 of the Green Party of Canada Constitution.
- k. "Give notice" means to inform by postal mail, telephone, electronic mail, or fax.
- l. "GPC Constitution" means the constitution adopted by the Green Party of Canada.
- m. "GPC" means the Green Party of Canada.
- n. "Lapsed member" means any person who has not been a member in good standing for less than one year. When a lapsed member rejoins within one year of lapsing, voting rights are restored immediately.
- o. "Leader" means the Leader of the GPC.
- p. "Meeting" means a meeting of members of an Electoral District Association called for the purpose of selecting, with or without competition, a GPC Candidate for that ED for any election.

q. "National Office of the GPC" means Green Party of Canada, 204-396 Cooper St., Ottawa, ON, K2P 2H7.

r. "Nomination Contest" means a competition for the selection of a person to be proposed to the GPC for endorsement as its Candidate in an ED.

s. "Nomination Contestant" has the meaning set out in the Act, and includes any person who has been approved by the GPC to be a contestant in a Nomination Contest.

t. "Nomination Contestant Applicant" means any person who has submitted completed Form A: Nomination Contestant Application, and completed Form B: Candidate Acceptance, a 300-word biography in electronic format, and any other documentation the GPC may require, by the deadlines established in these procedures.

u. "Ombuds and Appeal Committee" (OAC) means the committee created by Federal Council for the hearing of appeals.

v. "The Party" means the Green Party of Canada.

w. "Preferential Ballot" means a ballot in which voters rank a list of candidates in order of preference.

x. "Procedures" means these Nomination Procedures for the selection of Candidates for the GPC, including the forms attached hereto, which have been adopted by Federal Council.

y. "Regional Organizer" means any person employed by the GPC to organize a province or region and whose contact information is listed on the GPC website.

Nomination Meetings

3. Nomination Meetings

3.1. For the 41st General Election, EDAs shall conclude the nomination process as soon as possible. The timeline is as follows:

3.1.1 EDAs shall notify their members that a nomination contest in the riding is open for 4 days during which time applications will be accepted by the central office.

3.1.2. At the close of nominations the central party will have 1 day to process the applications. At the end of this period the central party will notify applicants and CEOs of approved nomination contestants.

3.1.3 If only one approved nomination contestant is put forward for the nomination contest, the contestant can be acclaimed by a unanimous vote of the executive of the EDA, in which case the EDA does not have to hold a nomination contest. EDAs should consider all of the potential benefits to the EDA and the Electoral District of holding a nomination contest before proceeding to an acclamation vote.

3.1.4 If more than one nomination contestant is approved, the EDA will immediately set a nomination meeting date for no less than 1 week and no more than 2 weeks after receiving notification of approved contestants. Members must be given at least 7 days notice of the nomination meeting.

3.1.5 The time line in Section 3 applies only to EDAs that have not yet opened nominations unless the EDA executive and all approved contestants agree to adopt the shortened time line in this section.

3.1.6. If an EDA does not secure a nomination by this process, the Campaign Committee may take what measures it sees fit to convene a Nomination Contest and secure a Nominated Candidate.

3.2. In the event a writ is dropped before candidate selection has been completed, the EDA or the Party may call a nomination meeting with 48 hours notice.

3.3. Candidate Search

3.6.1. EDAs shall conduct an acceptable search for nomination contestants, including women and/or minorities reflective of the demographic makeup of the local electorate.

3.6.2. Given the GPC's long-standing goal of achieving gender parity in its field of candidates, each EDA shall provide information to the Campaign Committee regarding its search for women candidates, including:

- a. the name and contact information of at least one woman approached to run by the EDA;
- b. the reasons given by women who declined to run for candidacy; and
- c. what women who were approached but declined say they would need in order to consider running in the future.

Nomination Contestant Application

4. Nomination Contestant Application

The Nomination Contestant Application form allows fast and efficient screening of all nominees before the Nomination Contest Meeting. Nomination Contest applicants shall submit completed versions of Form A: Nomination Contestant Application and Form B: Candidate Acceptance, and a 300-word biography (in electronic form), as early in the process as possible.

4.1. To be a Nomination Contestant, a person shall:

4.1.1. be a member in good standing with the GPC;

4.1.2. have fully and truthfully completed Form A: Nomination Contestant Application, and Form B:

Candidate Acceptance;

4.1.3. have submitted a biography of no more than 300 words, suitable for publication on the Party website, sent by email to candidate.bio@greenparty.ca.

4.1.4. be eligible for election to the House of Commons pursuant to all applicable provisions of the Canada Elections Act; and

4.1.5. have discharged all debts owed to the GPC.

4.2. Based on the submission of the items listed above, the Campaign Committee will determine the suitability of the prospective Nomination Contestant. Approval may be revoked at the Campaign Committee's discretion and in the interests of the Party, based on information received subsequent to the initial approval.

4.2.1. If applicable, a nomination contestant is entitled to a prompt explanation of why their application was not approved, but may not contest the decision. The EDA will also be notified, provided the contestant has given consent (on Form A).

Support for the Candidate

5. Support for the Candidate

5.1. EDAs shall provide organizational and financial support to the Party's candidate.

5.2. The EDA shall provide a list of current and lapsed members to each Nomination Contestant within 24 hours of the Contestant's approval by the Campaign Committee.

5.3. This list may be used by each Nomination Contestant and their designee(s) solely for the purposes of contacting eligible voting members to seek support for the Contestant, and of evaluating and contesting membership numbers and accuracy.

5.4. Within 48 hours of the deadline for submitting new voting memberships (30 days prior to the Nomination Meeting), the EDA shall provide each nomination contestant with the final list of members eligible to vote at the Nomination Meeting.

Meeting Officials

6. Meeting Officials

The GPC expects all nomination meetings to follow a fair and democratic process, and each shall include the following at a minimum.

6.1. The EDA will appoint a Meeting Chair and a Returning Officer, both of whom will refrain from any partisan activity on behalf of any Nomination Contestant.

6.2. The Returning Officer may appoint deputies and such other officials necessary for the conduct of the voting process, who shall refrain from partisan activity on behalf of any Nomination Contestant.

6.3. Each Nomination Contestant may appoint a number of representatives to be present at the taking of the vote and the counting of the ballots. During the taking of the vote, he or she is entitled to:

6.3.1. one representative for each voting/credentials verification station;

6.3.2. one chief representative; and

6.3.3. one representative to monitor the ballot box.

6.4. During the counting of the ballots, each nomination contestant is entitled to:

6.4.1. one representative for each counting station; and

6.4.2. one chief representative.

6.5. The chief representative of a Nomination Contestant at a Nomination Meeting shall be named in writing by the Nomination Contestant to the Returning Officer, and such individual shall have full authority to speak on behalf of the nomination contestant, and to bind the Nomination Contestant to any agreement he or she might be called upon to make on the Nomination Contestant's behalf, during the voting and counting processes.

Voting Members

7. Voting Members

7.1. Every member of the Party has the right to attend a Nomination Meeting and has the right to vote at that meeting if the member:

7.1.1. is present at the meeting;

7.1.2. has been a member of the Party for at least thirty days or has renewed a lapsed membership prior to, or at, the Nomination Meeting.

7.1.3. is ordinarily a resident of the Electoral District; and

7.1.4. has not voted at another candidate selection meeting held for the same election (except when the results of any such meeting are declared invalid).

7.2. Membership in the Party takes effect on the day the National Office of the GPC receives the fee and the membership application form.

Conduct of the Nomination Contest Meeting

8. Conduct of the Nomination Contest Meeting

8.1. All Meetings shall have the following parts, and may include additional parts:

8.1.1. Call to order by a member of the Executive of the EDA;

8.1.2. Introduction of the Meeting Chair, and of the Returning Officer;

8.1.3. Description by the Meeting Chair of the process to be followed at the Meeting, including:

8.1.3.1. time limits on nomination and seconding of Nomination Contestants;

8.1.3.2. time limits on speeches by Nomination Contestants;

8.1.3.3. restrictions on campaigning and

campaign materials in the voting area; and

8.1.3.4. the voting procedures and time for voting.

8.1.4. Nomination and seconding of Nomination Contestants;

8.1.5. Speeches by Nomination Contestants;

8.1.6. Voting;

8.1.7. Announcement of the successful candidate, by the Meeting Chair, who shall announce the number of ballots cast, the number of ballots ruled invalid, the number of tallies, and the name of the successful nomination contestant, without disclosing the number of votes received by any nomination contestant;

8.1.8. Remarks by the successful Candidate; and

8.1.9. Adjournment.

8.2. No business other than the selection of a candidate shall be conducted at the nomination meeting until after the vote for the candidate has been held.

Conduct of the Vote

9. Conduct of the Vote

9.1. In order to be granted a ballot, a person claiming to be an eligible voting member shall be required to produce satisfactory proof of identity, including place of ordinary residence unless all nomination contestants agree this is not necessary.

9.2. A pre-printed ballot shall be used containing the names of the nomination contestants in alphabetical order by surname. NOTA (None of the Above) as the last entry on the ballot may be included at the discretion of the EDA Executive.

9.3 The ballots in the election shall be counted under the direction of the Returning Officer.

9.4 The vote of eligible voting members to choose a Candidate for an Electoral District shall be conducted by one ballot only, which shall be a secret preferential ballot, and which shall contain the voting instructions.

9.5. Preferential ballots shall be counted in accordance with the following process:

a. Each ballot cast, on the initial tally, shall be counted in favour of the nomination contestant opposite whose name the voter has indicated a first-choice preference or a vote.

b. Prior to conducting each further tally as may be required in order to declare a nomination contestant elected, the Returning Officer shall declare eliminated the nomination contestant who received the least votes on the previous tally.

c. The Returning Officer shall reassign each vote received by a nomination contestant who has been declared eliminated to the remaining nomination contestant whose name appears on the ballot as the voter's highest remaining preference.

d. The Returning Officer shall conduct the appropriate calculations, and shall require such further tallies in accordance with these rules as may be necessary until a candidate is declared elected by virtue of having received a majority of the valid votes counted in that tally.

e. Where a vote tally gives rise to a tie vote among two or more nomination contestants, and the tie is relevant either to a declaration that a nomination contestant is eliminated pursuant to subrule (b), or is between the only remaining candidates, the Returning Officer shall toss a coin or use a system of drawing names from a receptacle to determine who will remain on a ballot or who, on a final tally, will be declared elected as the candidate.

9.6 Proxy voting is not permitted.

9.7 In EDAs where factors such as geography, weather and transportation hinder members from attending at a single location, the National Campaign Chair in consultation with the Campaign Committee may direct or, upon request from the EDA Executive may authorize, that the selection of the candidate take place at nomination meetings held at two or more times and locations, the first of which is the “First Nomination Meeting”. The methods of balloting to be used in these circumstances will be determined by the Campaign Committee.

9.8 Under extenuating circumstances other methods of balloting may be approved by the National Campaign Chair in consultation with the Campaign Committee.

Results of the Meeting

10. Results of the Meeting

10.1. The EDA shall submit the name of the nominated candidate to the regional organizer immediately upon completion of the meeting.

10.2. The Electoral District Association shall submit the form EC 20188-Nomination Contest Report to Elections Canada within 30 days of the nomination meeting in accordance with section 478.02 of the Elections Act.

10.3. If the nomination meeting fails to nominate a candidate, the EDA shall apply to the Campaign Committee for consent to call another Nomination Contest Meeting, and to determine the timeline in which to proceed.

Electoral Districts without Electoral District Associations

11. Electoral Districts without Electoral District Associations

11.1. Where there is no EDA, Nomination Contestant selection shall be conducted by a Nomination Contestant Meeting mandated by the Campaign Committee, except that if only one Nomination Contestant Applicant is approved, that contestant may be acclaimed and no Meeting is required.

Removal of a Nominated Candidate

12. Removal of a Nominated Candidate

12.1. A Nominated Candidate may only be removed with just cause, and by a 2/3 vote of Federal Council.

12.2. The Candidate is entitled to a prompt explanation of why their nomination or endorsement was revoked, but may not contest the decision.

Disclosure of Contributions and Expenses

13. Disclosure of Contributions and Expenses

13.1. Each Nomination Contestant shall comply with the financial reporting requirements of the Canada Elections Act.

Sanctions

14. Sanctions

14.1. If a nomination contestant or EDA executive fails to comply with the Canada Elections Act or these procedures, any disciplinary measures to be imposed will be, subject to applicable laws, at the discretion of the Campaign Committee and will take into consideration both the severity of the violation and the best interests of the GPC.

14.2. The disciplinary measures may include the disqualification of a successful Nomination Contestant, a declaration that another Nomination Contestant is to be the Candidate, the conduct of a new Nomination Meeting, and a prohibition against a person found to have been in violation of these rules being permitted to contest a new Nomination Meeting or a future Nomination Meeting in any Electoral District.

Appeals

15. Appeals

15.1. Should disputes over the candidate nomination and selection procedure arise, efforts should be made to resolve them at the local level. As a last resort, disputes may be referred to the Ombuds and Appeal Committee.

15.2. The OAC shall expeditiously deal with all appeals based on these procedures.

15.3. An appeal to the OAC shall only be commenced by notice of appeal in writing received not later than 72 hours after the time fixed for the commencement of a Nomination Meeting or, if a decision is made outside a Nomination Meeting, not later than 72 hours after the decision requiring review has been made. This time limitation is subject to extension at the discretion of the OAC, in accordance with its rules of procedure.

15.4. After a Nomination Meeting has been completed, only a Nomination Contestant or the Candidate may invoke the appeal process.

15.5. The delivery of a notice of appeal shall not cause a Nomination Meeting to be postponed or delayed unless specifically ordered by the OAC.

15.6. The OAC shall advise in writing the Leader, the Campaign Committee, the CEO of the EDA, the Nomination Contestants, and any other person deemed appropriate by the OAC, of an appeal.

15.7. Decisions of the OAC are final and not subject to appeal.

Electoral Urgency

16. Electoral Urgency

16.1. If the Campaign Committee determines that a situation of electoral urgency exists in Canada or in any Electoral District(s), it shall provide notice to the effect that such a state of electoral urgency exists. At minimum, such notice shall be provided to the Leader, the Chair of the Party, the Executive Director of the Party, and to the CEOs of all affected EDAs.

16.1.1. In any state of electoral urgency, the Campaign Committee may abridge the time limits or alter the procedures fixed by these Procedures in such manner as it may see fit, for any Electoral District(s), provided that any changes to these Procedures shall promptly be communicated to any affected EDA and to any potential Nomination Contestant (of whom the party has knowledge) who may be affected.

- (g) a person who is imprisoned in a correctional institution;
- (h) an election officer; and
- (i) a person who was a candidate in a previous election and for whom a return, report, document or declaration has not been provided under subsection 451(1), if the time and any extension for providing it have expired.

2. I understand that my approval as a Nomination Contestant does not constitute an agreement by the Green Party of Canada to the effect that the Party has in any way waived its right to designate a person other than myself as the Green Party of Canada Candidate in the next election or by-election.

3. I understand that I may be required, either before or after approval of my candidacy, to consent to any background checks that the Party considers to be appropriate and in the best interests of the Green Party of Canada. I further understand that the results of such background checks will be kept confidential by the Party unless, based upon information collected and in the best interests of the Party, I am not approved as a nomination contestant or candidate and, upon refusal of approval, I claim that the approval was refused without good reason. I understand and agree that the Campaign Committee or any person designated by the Campaign Committee may, upon receiving negative information as a result of such a background check, disclose such information to the Leader and to legal counsel in order to make a decision, but those individuals will not disclose that information, except in accordance with the foregoing.
